Guest Speaker Presentation

Speaker: Rashod Vaval, Supervisor, Chicago Park District

Topic: Overview of role and needs at Dunbar and Williams Parks

Oversight Responsibilities:

- Supervises Dunbar and Williams Parks
- Rashod is primarily based at Williams Park due to Dunbar's lack of a fieldhouse
- Manages:
 - o Rentals
 - Landscaping and lighting
 - Group coordination
 - General Park operations

Security & Safety Concerns:

- Dunbar Park earns ~\$100,000 annually from rentals but lacks permanent security
- Security provided by patrolling vehicles during peak times and rentals
- Limited early morning security: residents advised to call 911 in emergencies
- Off-duty officers may provide unarmed security for events
- Large unpermitted gatherings remain a challenge; residents encouraged to report issues
- Rashod committed to routine check-ins and support for future meetings/events

Park Challenges:

- Ongoing post-holiday cleanup issues at Williams Park
- Recurring safety concerns
- Next coordination event scheduled for **September** at Williams Park

District Council Member Updates

Sarah Kammerer, Chair

- Role Overview: facilitates dialogue between the community and police to build trust, accountability, and transparency. stressed the importance of community feedback.
 - o Goal is to meet residents where they are, whether at monthly meetings, individual meetings or through the feedback form
- Activities included meetings residents, resident HOAs, businesses, building management, event organizers, and park officials
- Asked attendees to community facilitate introductions.
- Provided an overview of the police department's strategic plan, prioritizing quality of life issues, motor vehicle theft in specific regions, and robbery prevention.
- Common concerns: Increasing comfort in public spaces; increasing concern about pedestrian safety including cars speeding and not stopping at stop signs, scooters and bikes on the sidewalks
- Discussed 001CPD Stratgetic Priorities: reaffirmed top district priorities from fall session feedback (150+ participants) that include nuisance and disturbance complaints, car thefts (mid-district concentration), increased robberies (northern district) and asked for input

Jamie Brown, Community Engagement

- Focused on enhancing summer community participation
- Noted:
 - CPD resource limitations due to seasonal demand
- Provided updates on:
 - Proposed soccer stadium at "The 78"
 (Community meeting with Ald. Dowell pending)
 - Sheriff's satellite office opening at Roosevelt CTA station
 - Ongoing CTA safety issues (e.g., overdoses, robberies)
 - Collaboration with CTA on data collection and funding safety programming

Adrienne Johnson, Nominating Committee

- Reported lack of quorum at recent nominating check-in
- Full committee meeting scheduled for **June 7**
- Early planning underway to recruit 2026 commissioners:
 - o 2 youth members
 - 1 north-side attorney
- Improving digital outreach via:
 - Facebook
 - QR code-based feedback tools
- Council collaborating with CAPS leadership to develop outreach strategies

Discussion

Staffing & Enforcement:

- Reduced traffic enforcement staffing in recent years
- CDOT increasingly relies on infrastructure (e.g., signage, curb bump-outs)

Technology & Education:

- Speed cameras continue to be used
- Stop sign cameras remain controversial
- Education prioritized as key to sustainable safety

Community Feedback:

- Resident concerns included:
 - Unsafe e-bike/motorbike use on sidewalks
 - "Last mile" safety challenges for pedestrians and transit users
 - Limited traffic enforcement in high-risk areas
