#### **Public Comment**

- Priscilla Mims: Pris raised concerns about motorcycles in Lakeshore East Park on August 4 around 4PM. There were about 100 motorcycles that went East on Lower Wacker and ran a number of stoplights, including a number of bikes that went down the steps into the Park where families and children were playing. Called CPD and filed a report. Also raised concerns about Mexican Independence Day.
- Tom Prenzno: Tom is frustrated about traffic management in general, including gridlock around special events (named Lollapalooza) and increased volume of traffic. He is most concered about pedestrian safety, both in crosswalks, as well as motorcycles and e-bikes and scooters.
- **Jim Hutchinson:** Jim notes that there are contractors that are parking illegally all day, on both sides of Harbor Drive and close to crosswalks, making it hard for drivers to see pedestrians. In addition, durlong Lolla, there was a contractor parked in Cancer Survivor's Garden, but never saw any workers around. Would like the parking enforcement rules to apply them.

## **District Council Updates**

#### Sarah Kammerer, Chair

- DC Overview:
  - o District Boundaries: Defined as the Chicago River South to 31st Street and from Lake Michigan to the highway.
  - o Facilitates dialogue between the community and police to build trust, accountability, and transparency. Stressed the importance of community feedback.
  - o Engagement Methods: Encouraged participation through monthly public meetings, community events, feedback forms, and direct communication (emails, phone calls, informal meetings).
  - o Asked attendees to community facilitate introductions.
- Provided an overview of the police department's strategic plan, prioritizing quality of life issues, motor vehicle theft in specific regions, and robbery prevention.
- Activities included participation in condo board meetings, LSE Presidents Group monthly meetings, Chicago Loop Alliance Public Safety Group, and other stakeholder meetings. She also attended a number of community and building events.
- Biggest Issues: pedestrian safety, motorcycles, large event nuisance including traffic and noise
