Sarah Kammerer, Chair

- DC Overview: District Boundaries: Defined as the Chicago River South to 31st Street and from Lake Michigan to the highway; facilitates dialogue between the community and police to build trust, accountability, and transparency. Stressed the importance of community feedback; encouraged participation through monthly public meetings, community events, feedback forms, and direct communication (emails, phone calls, informal meetings); asked attendees to community facilitate introductions.
- District Strategic Plan: provided an overview of the police department's strategic plan, prioritizing quality of life issues, motor vehicle theft in specific regions, and robbery

- prevention; encouraged individuals from 3rd sector to participate to ensure their concerns are heard and resources are provided
- Activities: participation in condo board meetings, LSE Presidents Group monthly

- Biggest Issues: pedestrian safety, motorcycles, large event nuisance including traffic and noise, Mexican Independence Day preparation and concerns with Federal intervention

- Biggest Issues: concerns with pop-up protests, specifically protests that are not permitted: this needs to be enforced; crossing guards removed from elementary schools (Note: note sure if 001 is affected an this is a CPS not a CPD issue, but also related to pedestrian safety); CTA crime

- Social: FB page for District Council 001 CCPSA (9/9/2025; new update!): 33 followers (increased 3% from previous 28 days and 31 followers in August)

Discussion

Key Concerns Based on Community Feedback:

- Violence Response: Concerns with violence in neighborhood; CPD staffs the area (HUD Funded) but the car doesnt respond and the security that are hired to help keep tensions low are hanging out with the kids that are the trouble; when incidents do happen, the community members can't report the crime to the car, they have go to the station; there is a bullet hole in the park district window; the violence plagues the community but we need help with accountability; don't have updated technology, waiting for updates from Park District
- Pedestrian Safety: bikes and scooter on sidewalks, speeding cars, cars not stopping for pedestrians
- CTA: smoking, loud music and violence is an issue; people don't want to ride in these conditions
- Homeless Population: why can't we get people the services we need?
