District Council Member Updates

Crisis Assistance Response and Engagement (CARE)

CARE is going through a rebuilding period to ensure its effectiveness. Efforts Include:

- Building staffing levels
 - Working towards eight vans six that work to answer emergency calls and two that can proactively be present in the community
- Increasing call volume
 - Current call types include: Mental Health Disturbance, Criminal Tresspassing, Threatening Suicide, Well Being Check, Nonviolent Suspicious Person
 - How to appropriately handle "weapons unknown"
 - Planning an Intercity Risk Mitigation Meeting
 - Create an effective process for Police Assists (when police call CARE to the scene)
 - Advocate for the Commission to create CPD goals related to this need.

Letter to CCPSA: CPD Interactions with ICE/CBP

- Chicago and Illinois law bar local law enforcement from assisting federal immigration operations.
- 19th District Councilors joined majority of District Councilors citywide signing a letter to the CCPSA requesting a meeting to discuss CPD's interactions with federal immigration enforcement.
- Meeting would allow for community members and CPD to provide information, and for CCPSA to consider policy options clarifying CPD's role.

Immigration agents swarm Little Village and Cicero, arresting at least 7, including US citizens

Chicago Ald. Mike Rodríguez, 22nd Ward, who represents Little Village on the City Council, called for the release of two of his staffers — Jacqueline López and Elianne Bahena who he said were detained by federal agents.

Bahena, a U.S citizen, is also the elected district council member for the 10th Police District. Her whereabouts have not been confirmed, the Community Commission for Public Safety and Accountability said in a statement, which also demanded her release.



Office of Constitutional Policing and Reform (OCPR): 7%







The **Bureau of Patrol** is the Department's largest component, delivering front-line services across Chicago's 22 police districts.



The **Bureau of Detectives** is responsible for conducting investigative follow-ups on criminal cases.












The **Office of Chief of Staff** provides legal, operational, and strategic support to the Superintendent by managing scheduling, budgeting, communications, external coordination, and risk management.





Department Wide Staffing Levels








CAPS Tactical Admin Desk (Community **Teams Policing**) **District Timekeeper Squadrol Detention** Intelligence Officer Watch **Bike Unit Patrol Other Units** Secretary

Unit	Role and Responsibilities
Admin 7 sworn 6 civilian	The Commander oversees the district's relationships and deployment of resources based on strategic priorities. Support staff handle complaint reviews, crime analysis, and administrative tasks like processing citations and telephone reports.
Detention 17 civilian	This unit manages the detention facility for temporarily holding arrested individuals, ensuring that male and female prisoners are kept isolated. Staffing consists of civilian Detention Aides who work 8-hour shifts and must maintain a minimum of two on duty at all times.
Watch Secretary 9 sworn	These personnel act as assistants to patrol watch lieutenants, handling various administrative duties like managing rosters, leave requests, and phone calls. They are also responsible for running errands necessary for the functioning of the watch.

Unit	Role and Responsibilities
Desk 17 sworn 4 civilian	This section staffs the station's front counter 24/7 to handle walk-in reports, provide customer service, and ensure station security. They also manage the radios for patrol personnel, including logging assignments and recharging batteries.
Timekeeper 1 sworn 1 civilian	Timekeeper officers and civilian counterparts are responsible for performing data entry for personnel management tasks. This includes processing timecards, leave, and overtime data.
Patrol 161 sworn	Patrol officers respond to all community-generated emergency and non-emergency calls for service while routinely engaging in proactive crime and quality-of-life efforts. Lieutenants serve as watch commanders, and Sergeants act as first-line supervisors who respond to calls and review reports.

Unit	Role and Responsibilities
Tactical Teams 33 sworn	This team responds to priority events, conducts proactive crime suppression missions, and is the primary unit deployed to citywide special events. Sergeants lead the teams to identify and coordinate proactive work priorities in unmarked, uniformed vehicles.
DIO 2 sworn	District Intelligence Officers support the Tactical Teams by identifying critical priorities and actionable intelligence for the teams. They also maintain an updated map of gang activity and a list of the district's top violent offenders.
Bike Unit 19 sworn	This is a specialized detail deployed in specific areas, operating largely in a proactive capacity within 4th watch. Officers conduct stops, maintain a high presence, and address local issues within their assigned areas.

Unit	Role and Responsibilities
CAPS 6 sworn	This group fosters community engagement, coordinates outreach, and staffs various specific liaison roles (e.g., domestic violence, youth, business, faith-based, and older adults). CAPS personnel are assigned district wide and do not have individual areas of responsibility.
Squadrol 1 sworn	Squadrol units operate prisoner transport vans (wagons). They are deployed within the district or city wide as needed for events, relieving officers of making transport to detention.
Other Units 1 sworn	Additional details that are staffed at the discretion of the district commander. It is understood that, given the flexible nature of the assignment, the data recording these assignments is not consistently updated.


Rules of Engagement

- 2 min/speaker = ~10 speakers (typically 20 minutes total)
- Request to make public comment must be submitted within 30-minutes of start of meeting
- Order of speakers randomly selected
- No disruption of speakers
- No harassment or disrespect will be tolerated (zero tolerance policy)

Follow Up

- District Councilors and staff will take official minutes of public comments made
- District Councilors may address comments in real time or may follow up with community member at a later time
