Guest speakers – City of Chicago Office of Emergency Management Communications (OEMC)

- Andrew Johnson, Leslie Kittling - Dispatchers
 - Call 911 anywhere in the city within cell tower
 - On busy days, when towers are overloaded, location may not be as exact
 - Sometimes they can retriangulate
 - 1st - they have to find caller
 - Do you want to be anonymous or not?
 - Can't do it if you want them to come to you, or;
 - If you want to file a complaint
 - Reporting info:
 - Shoes are important – people can change clothes quickly; shoes not as much
 - When did it happen? Timing is important
- Discussion / Q&A
- Cole Park shooting incident
 - Dispatchers gave out a lot of detail on scanner
 - Officer on scene asked about Pod cameras
- How calls are categorized
 - Priority 1 - imminent threat to life or property
 - Injuries, fires
 - Priority 2 - in progress
 - Gang disturbances
 - Burglar alarm
 - Priority 3
 - "Nuisance calls" - because they call often
 - Everything else including municipal / 311 calls
 - Sandra Wortham - has called about unpermitted parties at Cole Park; Park District is supposed to post schedule of permitted events
 - Ciera Whitaker – collaboration is needed
 - Other – park events should have security
 - Everyone should call
- Other numbers
 - 988 - suicide help

- 211 - humanitarian
 - Food pantries
 - Help w/ services / child care / employment
- Q: Are calls for service recorded?
 - Two types of calls for service:
 - Shotspotter - software auto generates an event that goes through system
 - Computer aided dispatch (CAD)
 - Sgt. Keith Seals (CPD) - Shotspotter also goes off in SDSC room
