F. Discussion on the CCPSA leadership elections.

- a. DC25: Northwest Working Group interested in discussing how the nominators can influence the selection of the CCPSA's leadership.
 - i. DC22: Might go against CCPSA's bylaws. Based on experience, the DCs already influence the Commissioners and their work, but that's up to each District Council.
 - ii. DC06: It is important to separate the accountability conversation between what is relevant to the Nominating Committee and to all District Councils. For example, the District Council Vacancy process. That process has been impacted by the Mayor's Office and all of us could be impacted.
 - iii. DC01: Given that the nominations to leadership have been made, what should our role be? Is DC25 looking for something where each Council votes to give the leaders of the Commission their approval?
 - iv. DC25: If we could see a report card, then we can have that conversation about the merits of each Commissioner to serve on the executive.

- v. DC01: I would have liked to see the product of the discussion generated at the last quarterly. That would have been helpful for us to have.
- vi. DC19: I think we would need to meet more often to be able to have any feedback to give to the Commission. As nominators, we are the only body of the District Councils that has hard power over who gets to be a Commissioners. I think that there needs to be more than a 2-minute public comment section for district councils to speak. Perhaps they can set time on the agenda to hear from the councilors. In general, I think we all do have a role to play in requesting more information.
- vii. DC17: I do think we clearly set priorities for them, and there has been little progress on these priorities. I do believe that we are the body who should call them out as to why they have not made progress. The executive should be particularly accountable.
- viii. DC14: I wonder if there is a world where nominators endorse a nominee to the role of the executive. I think Councils are often left in the dark as to what type of work the Commissioners are doing, and where they are spending their time.
- ix. DC20: Can we table this and set more time in the future?
- x. DC04: I think if the Commissioners are not supporting our need for more communication, then we might not have more to offer.
- xi. DC17: I think the issue is not which Commissioners are attending their monthly meetings, but rather what the attendance at the working groups looks like.
- xii. DC22: I have brought up the issue with Commissioner Minor not attending the hate crime working group. I brought this up during the last Commission meeting but got no answer.
- xiii. DC12: I think we did put these people in these positions. I think we could issue a letter of support or of no-confidence. Our constituents are telling us that we need to hold them accountable.
- xiv. DC14: I think we might not be able to enforce much, but they should at least hear our concerns and hear how our constituents feel.
- xv. DC25: To DC14's point, we are able to endorse and have influence over who is on the Commission's leadership based on the ordinance.
- xvi. DC06: We might be able to consider this and apply edits to the interview and application questions.
- xvii. DC19: I think folks in this body who are interested in the conversation need to have a separate conversation.
- xviii. DC06: I think that we can discuss the ordinance at the next meeting. We need to discuss if we (DCs) want to say something about it.

- a. DC14: Create a survey for what constituents want to see in future constituents.
