Executive Summary

May 2026 District Council Monthly Report

District Councils met across the city in May, producing a citywide picture of where communities and local public safety priorities currently stand.

Top Citywide Trends

Mental health crisis response and the expansion of the CARE Program, as well as theft (airbags, catalytic converters, vehicle break-ins) topped this month's concerns, each cited in 6 of 22 districts. Gun violence, shootings and youth safety, and violence and public space followed in 5 districts each, with several councils proactively pairing these concerns with mentorship and block-organizing strategies ahead of summer. Homelessness and police accountability followed in 4 districts each. Robberies, domestic violence, CTA safety, and traffic safety followed in 3 each.

Nominating Committee Business

Anjanette Young and Angelique Guzman advanced through City Council and were confirmed in May. The Nominating Committee is waiting to hear back from the Mayor's Office on the third vacancy.

Council Operations

Of the 22 District Councils, 19 held official council meetings in May. DC 008's meeting was cancelled, and DC 007 and DC 010 did not meet quorum and instead held community meetings in lieu of official business. DC 015 completed a smooth chair transition. DC 003 and DC 012 still each have one vacant seat. Several councils have disseminated information about the upcoming DC elections.

Recommendations to Watch

This month's submitted recommendations cluster around three asks: expanded CARE hours/coverage and clearer dispatch protocols (DC 014, DC 017, DC 018, DC 019, DC 024), increased data transparency from CPD (beat-level crime data, District Strategic Plan metrics, consent decree compliance (DC 009, DC 016, DC 017), and continued support for the Victims Bill of Rights (DC 012, DC 014, DC 017).

Working Groups

As of the end of May, all ten active working groups reported progress this month. Notable upcoming milestones include the Community Policing working group's first meeting with CPD and the District Strategic Plan Working Group's meeting with CPD, both scheduled for June. Outcomes from these meetings will be reported in the June Monthly Report.

Purpose, Process, and Background

The purpose of the DC monthly report is to ensure the Commission receives community input from residents of all twenty-two districts. The findings contained within are a reflection of the issues raised by Chicagoans who engaged with District Councils in the last month and do not come from a statistical sample of all Chicagoans.

With the production of this report, District Councils fulfill their purpose under the CCPSA Ordinance to ensure regular community input for efforts of the Community Commission for Public Safety and Accountability, as outlined in Municipal Code of Chicago §2-80-070(a)(3). The report also caters to the responsibility of District Councils to report their findings, conclusions, and recommendations to the Commission, as outlined in §2-80-070(e)(8). Additionally, the findings in this report provide District Councils with the means to identify opportunities for cross-district collaborations, including forming working groups to focus on specific issues raised by residents across the city.

The information contained in this report comes directly from the monthly public meetings of District Councils. By Ordinance, District Councils must hold monthly meetings to provide a forum for residents to raise and work to address concerns about policing. District Councils also use these meetings to share updates on their activities from the last month and to discuss and at times vote on recommendations for the Commission and other bodies of government. This report provides a summary of this information from the regular monthly meetings of each District Council. In cases where a District Council had to cancel a meeting, the Councilors provide findings based on any other outreach activities they conducted from the previous month. District Councils have an opportunity to review their individual updates before the finalization of this report. The notes in the individual updates do not represent the approved minutes of the meeting. District Councils approve meeting minutes at future dates in a manner consistent with the Illinois Open Meetings Act. This report represents a timely update to the Commission and other District Councils of findings, updates, and decisions at the meetings.

In compiling this report, CCPSA staff assess any notable trends from across the districts. The report may highlight recurring concerns and focuses raised by residents across the city. CCPSA staff may categorize findings to illustrate these trends. This exercise helps the Commission, the District Councils, CCPSA staff, and all other readers with key insights from the work of District Councils. Readers are encouraged to review the individual Council updates themselves as well to look for other potential recurring themes from community input gathered by District Councils.

This report also aids the District Councils in holding Quarterly Meetings. By CCPSA Ordinance, and as outlined under §2-80-070(e)(3), representatives from all twenty-two District Councils hold quarterly gatherings to identify trends and concerns from the previous quarter. Quarterly Meetings are organized by the DC Planning Team for Quarterly and Annual Meetings, a geographically diverse group of eight District Councilors chosen to represent general regions of the city. The Planning Team reviews these reports to determine the most significant trends and concerns raised by residents. District Councils discuss these key findings at their quarterly gatherings and work to identify potential solutions and strategies for addressing the concerns and trends identified.

While CCPSA endeavors to ensure this report is as thorough as possible, the data and information contained in the report are only a reflection of the input received and gathered by District Councils via community outreach and public meetings. This report is not a representative statistical sample of the concerns across each district. The Commission and any other readers of this report may consider other strategies and sources of information to gauge the needs and interests of Chicagoans. That said, this report serves an important function of showcasing what the District Councils learned in the past month and what the top concerns were of individuals who chose to interact with the District Council program.

District Councils act as the eyes and ears of their communities at a hyper-local level, providing critical insight that helps shape efforts to increase public safety and improve the future of policing in Chicago. The findings from this report help to ensure that public safety, policing, and police accountability policies and initiatives reflect the lived experiences of residents across the city.

PUSH NOTIFICATIONS

PARKING ALTERNATIVE RESPONSE TEAM (PART)

Purpose: This working group supports efforts to create a Parking Alternative Response Team (PART) that would shift parking-related 911 calls away from sworn officers to civilian responders, freeing up officer time for higher-priority calls.

Update: The group is awaiting a proposal from the Mayor's Office on which parking violations could be reclassified to support implementation, with the goal of passing an ordinance in June. The group is also exploring philanthropic and aldermanic partnerships to help fund a pilot program.

CARE — MENTAL HEALTH ALTERNATIVE RESPONSE

QUARTERLY & ANNUAL MEETINGS

Purpose: This working group fulfills the ordinance obligation to identify and discuss citywide public safety trends on a quarterly basis and to propose Commission priorities on an annual basis.

Update: The next Quarterly Meeting is scheduled for June 27 on the Southeast Side, with venue details still being finalized. Fourteen priority proposals have been submitted and are under review by staff. District Councilors who submitted proposals will present their ideas for feedback at the June meeting, and the Deputy Mayor of Community Safety has been invited to attend.

COPA MEDIATION PROGRAM

Purpose: This working group collaborates with COPA and Commissioners on the development of the COPA Community-Police Mediation pilot program, which aims to connect community members and police officers through restorative justice practices for low-level complaints.

Update: Eleven community mediators have been selected, with additional applicants joining a mentorship cohort to build skills for future participation. Mediations are expected to begin as early as August.

RESTORATIVE JUSTICE COMMUNITY COURTS (RJCC)

Update: The group is working to obtain clarity from CPD on implementation plans and timelines. The first in-person meeting with CPD is scheduled for June 12.

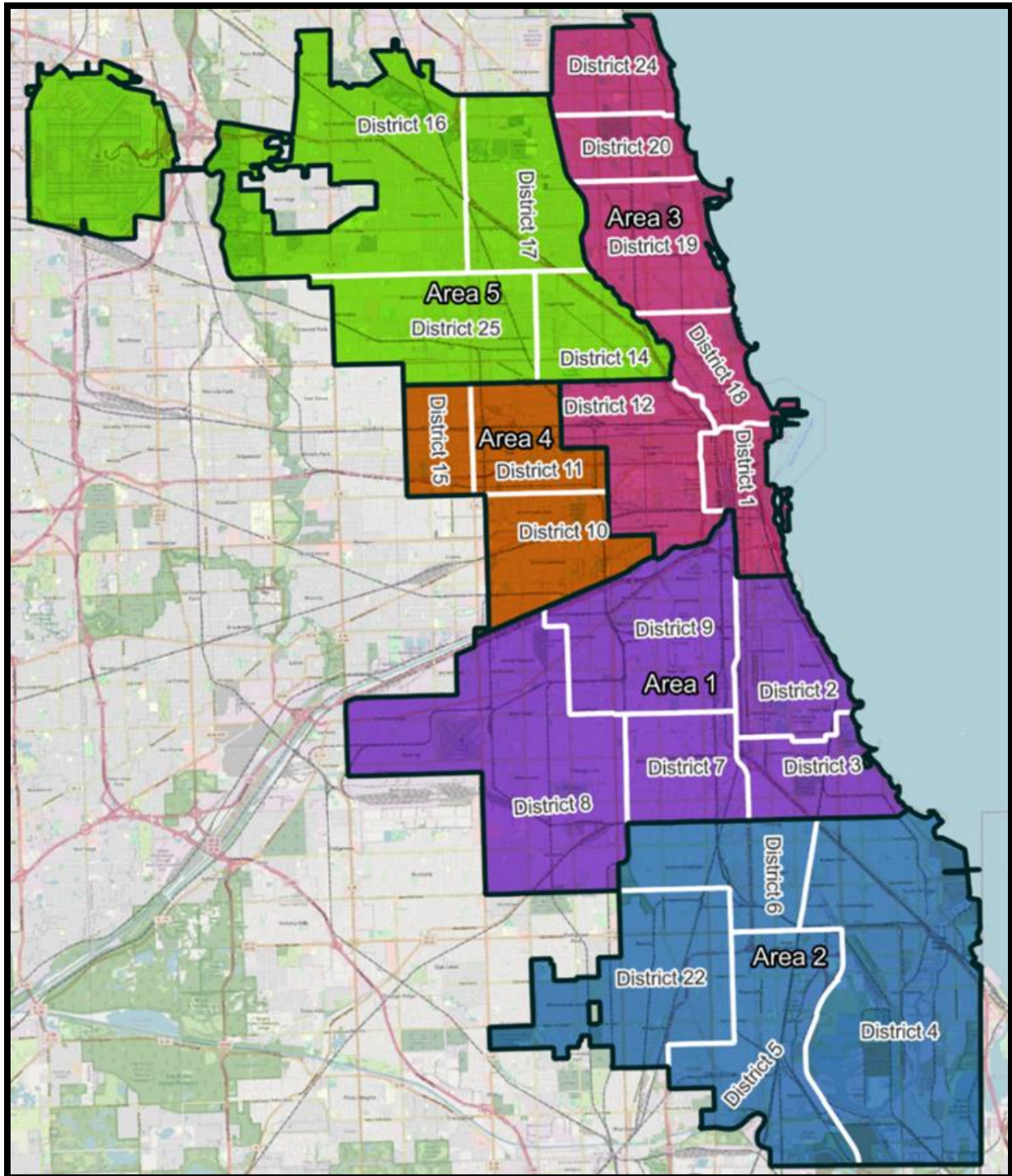
Purpose: This working group works to improve the effectiveness of CPD's District Strategic Plans by providing recommendations aligned with community needs.

 - b. OIG noted investigations are confidential under municipal code, that it received and responded in writing to CCPSA's referral on the matter, and that the Independent Monitoring Team led by Maggie Hickey oversees consent decree compliance separately from OIG

Top Trends & Concerns Discussed in Monthly Meeting

- i. **Police Response Time**
 - a. Community members raised concern that personnel cuts and increased administrative workload have slowed police response, particularly to incidents on CTA Red and Blue Line trains
 - b. Residents recalled historically faster response to train incidents and linked current response times to declining CTA ridership
 - c. Request for greater visibility of positive police response outcomes (e.g., media coverage of successful arrests) to help rebuild community trust
- ii. **CIT (Crisis Intervention Team) Dispatch & Training**
 - a. Community member shared a firsthand account of requesting CIT-trained officers for a drug-related mental health crisis and instead receiving non-CIT officers
 - b. Responding officers expressed confusion about whether drug-related incidents fall under CIT's scope
 - c. A CIT-trained officer arrived only after the situation had been resolved by non-CIT officers
 - d. Concern raised about inadequate CIT dispatch protocols and officer understanding of CIT's role
- iii. **CTA Security & Rider Trust**
 - a. Private security contract on CTA has ended, with CPD reassuming responsibility for train and station security
 - b. Lack of clear public communication about the transition and what to expect going forward
 - c. Broader concern that declining trust in CTA reliability and safety requires system-wide improvements, not policing alone
- iv. **Unhoused Populations & Service Gaps Near Howard Red Line**
 - a. Continued concern about unhoused individuals using CTA overnight for shelter, with policy requiring riders to exit at terminal stations leaving people with nowhere to go late at night
 - b. Concern about limited Narcan access in the Howard area, with the nearest location too far for timely use
 - c. Interest in increasing access to restrooms and public facilities near Howard, including potential porta-potty installation
- v. **Domestic Violence & Gender-Based Violence Reporting**
 - a. CCPSA-wide data presented showing significant increases (34–46% by ward) in hotline calls related to domestic and gender-based violence
 - b. Increases likely reflect both greater awareness/reporting and increased need
 - c. Continued advocacy for holistic, non-criminal-justice-centered support services, including services accessible to non-English speakers
- vi. **Traffic Safety & Red Light Violations**
 - a. Resident-reported repeated red light violations on Sheridan, including a specific recurring offender observed during morning commutes

- b. Discussion of catalytic converter and airbag thefts as an ongoing vehicle crime concern in the district

Councilor Reports

- i. **CPD Coordination & Community Concerns - Councilor Jean-Joseph**
 - a. Met with CPD Commander to raise community concerns, including reports of unhoused individuals being ticketed on the Red Line; CPD indicated tickets are not issued for sleeping on trains but may be issued for related conduct (e.g., smoking, drinking, moving through train cars), and requested specific examples for follow-up
 - b. Raised concern about limited Narcan access near the Howard Red Line and discussed coordinating with Ald. Maria Hadden's office on potential solutions
 - c. Coordinating with CPD and Ald. Hadden's office on increased enforcement, signage, and additional presence to address red light violations on Sheridan
 - d. Working to schedule a free catalytic converter serial-number engraving event with CPD/CAPS, with a tentative date of May 30 pending CAPS scheduling
 - e. Submitted a Letter of Intent for a \$50,000 University of Virginia public safety/urban violence grant focused on beautification, outreach, and resource access in the Howard Red Line area
 - f. Presented public comment at a CCPSA meeting on hotline data showing significant ward-level increases in domestic and gender-based violence calls, and advocated for expanded, holistic, language-accessible support services
 - g. Council continuing to collect petitions for expanded CARE program hours and vehicle capacity, noting CARE remains limited to weekdays, 10am–4:30pm with only one to two vans citywide
- ii. **Community Outreach & Engagement – Councilor Arreola**
 - a. Council tabled at the Rogers Park Carnival to raise awareness, collect feedback, and grow community mailing list
 - b. Continued monthly meetings with CPD leadership to discuss local concerns
 - c. Community feedback included a desire for more visible, engaged police presence (e.g., officers on foot) rather than presence limited to patrol vehicles
- iii. **Grant & Resource Development – Council**
 - a. Letter of Intent submitted for \$50,000 University of Virginia grant; council awaiting word on invitation to submit a full proposal
 - b. Continued coordination with A Just Harvest and other community organizations on outreach to unhoused residents and returning citizens post-incarceration
